### Explanation of Responses:

1. This amendment is filed solely to correct the typos regarding the number of restricted stock units in Table I, column 4, which were incorrectly stated in the Form 4 filed on August 5, 2022. 2. This amendment also updates and corrects the total shares held in Table 1, column 5, including the resulting inaccuracies from the typo in column 4. Pursuant to the Issuer's Non-employee Director Compensation Policy and in connection with the Reporting Person's resignation as a Class II director of the board of directors of the Issuer on August 3, 2022, the cancellation of the 2,548 unvested restricted stock units is reflected as a reduction to the number of the Reporting Person's shares of common stock.
